Course Summary

Course Description	This course is intended to introduce students to the basic concepts and problems of business law and of the legal system. The course will provide an overview of the laws that shape the way business is carried on, the manner in which business affairs and management s are mediated by relevant legal mechanism. This course will examine the important legal aspects of business affairs with special emphasis on contract law , tort law and corporation law . Please note that there are no particular official textbooks for this course. Very detailed lecture notes will be provided for each class. All students will be asked to complete the review of each lecture's notes before attending the class. You MUST have the lecture notes when you come to class, as each class will proceed on the basis of the lecture notes!!!!
Description Related Courses	This course is basically related to the understanding of the American legal system.
Course Goals	This course is designed to provide students with a solid foundation in understanding the legal issues related to topics of business law . Areas of study will include how laws were formed, procedures in civil cases, making contracts, terminating contracts, responsibilities

	of minors, being a consumer, purchasing power, purchasing insurance, tort claims, starting a business and structure of corporation law.
Projected Results	At the completion of this course, a student will be able to identify the fundamental principles of the U.S legal system; describe and discuss the laws which apply to business persons; explain the terminology associated with business law; give examples of realistic and practical applications of legal concepts; research, analyze, and interpret case law.
