Course Summary

Course Description	This course is primarily concerned with the questions of how international disputes are mediated and resolved within the framework of international law . By focusing on the diverse mechanisms and procedures for the resolution of deputes in international law , this course will provide principles and rules of international law for settling disputes in international society. Given that law can be served as critical for the resolution of various disputes in a society,understanding of the dispute settlement mechanisms under international law could provide a critical opportunity with the students to examine the nature of contemporary international society.
Description Related Courses	This course is also related to the understanding of international law , international human rights law and international trade law .

Course Goals	This course will examine the diverse mechanisms and procedures for the resolution of international disputes. The purpose of this course will provide critical foundations for the resolution of international disputes under contemporary international legal order, thereby providing a deeper understanding of the nature of international society.
Projected Results	Through this course, it is expected that the students will gain basic knowledge of the dispute settlement mechanisms and procedures under contemporary international law, so that they could cope with diverse international problems in terms of resolution of international disputes. This is critical in that the globalization phenomena of legalization have asked the students to gain intellectual power to cope with diverse international legal problems out of constant disputes and conflicts in the international society.
